3. WHERE TO USE

Liquid Weed & Feed may be used on bentgrass, bermudagrass, Kentucky bluegrass, fescues, perennial ryegrass, and St. Augustinegrass lawns, vacant lots, playgrounds where broadleaf weeds are present. Liquid Weed & Feed controls listed broadleaf weeds, including sensitive weeds such as chickweed, clover, dandelion, knotweed and plantain.

4. WHEN TO USE

- 1. Spray during the growing season when weeds are actively

5.2 FOR BERMUDAGRASS, KENTUCKY BLUEGRASS,

Apply 13 fluid ounces (26 tablespoons) of product per 1,000 square feet of turfgrass. This product at this rate provides 0.195 pounds of nitrogen per 1,000 square feet per application. One quart of product will treat up to 2,500 square feet of turforass.
